FISCAL YEAR 07.01.20 - 06.30.21

Despite the challenges brought on by the ongoing COVID pandemic, we have achieved so much this past year. In March and April, our Forensic Interview team successfully interviewed over 150 clients each month, the most children ever in the history of the Center. Also in the spring, our Family Advocacy and Support Services department provided 57% more services compared to the same time last year. Then in June, we were thrilled to break ground on our second, full-service Center in McKinney, which will provide services to children and families in the rapid-growing northern part of our county, helping us ensure that we can meet the needs of Collin County's most vulnerable now, and for years into the future.

Throughout this past year we have remained committed to ensuring that all client services and projects continued in a safe and socially distanced manner so we could continue to meet the critical needs of children and families victimized by child abuse. This next year is one of change and rapid growth, and we are excited to celebrate our monumental 30th anniversary. With changes and milestones ahead of us, we continue to look toward the future of our community's children and remain steadfast in our commitment of being a safe haven to those we serve so that no abused child in Collin County ever goes without the services they need to heal.
