This past year at Children’s Advocacy Center of Collin County was a testament to the resilience of our clients, the strength of our team, and the commitment of our supporters. Although the worst of the COVID pandemic is behind us, economic uncertainty and financial conditions remained a challenge for our community. Yet with your support, we were able to achieve great things. We continued to offer services to all children and families who needed our help as reports of abuse continued to climb. Progress remained steady on the construction of our second, full-service Center in McKinney, which broke ground in June 2021. At capacity, this facility will allow us to provide more accessible services to children living in the northern part of Collin County, with projections estimating that up to 60% of our services may be provided from there due to the rapid population growth in the northern part of Collin County.

From our humble beginnings in 1992 as a project of the Junior League of Plano to serving almost 4,000 clients per year, we are honored to have grown along with Collin County through the decades. In spite of our growth, we remain committed to one very important thing – ensuring that children experiencing abuse and neglect in our community have access to safety, healing, and justice.
