



LEXUS RAFFLE OFFICIAL RULES

Odds of Winning: 1 in 2,750. Need not be present to win. Please make checks payable to:
Children's Advocacy Center of Collin County or CACCC.

1. ELIGIBILITY: Entrants in the CACCC Vehicle Raffle (the "Raffle") must be legal U.S. Texas residents who are at least 18 years of age on or before April 6, 2024, and who are licensed drivers possessing a valid U.S. driver's license. Employees of Sponsor (as defined below), Southern Area Lexus Dealer Advertising Association, Inc., Toyota Motor Sales, and their parent companies, subsidiaries, affiliates, divisions, advertising and promotion, and fulfillment and/or judging agencies (hereinafter, "Related Entities") and their spouses are not eligible. The Raffle shall be subject to applicable federal, state and local laws and regulations. The Raffle is void outside of the U.S. and where prohibited or restricted by law.

2. SPONSOR: Children's Advocacy Center of Collin County (CACCC), 2205 Los Rios, Plano, TX 75074 (hereinafter referred to as "Sponsor").

3. HOW TO ENTER: To enter the Raffle, complete and submit the printed entry form at the bottom of this card by no later than 11:59 p.m. Central Time on April 6, 2024. Once you have completed the entry form and have submitted the form as directed, your entry will be complete (hereinafter, "Entry"). Entry can also be completed by going to caccollincounty.org. There is no limit on the number of Entries you can submit; however, each Entry must be submitted separately. Entries generated by script, macro, or other automated means will be void. All Entries become the property of Sponsor and will not be returned.

4. WINNER SELECTION: The potential Grand Prize winner will be chosen at random from all eligible Entries in accordance with these Official Rules. The winner selection will be made by a designated representative of Sponsor on April 6, 2024.

5. ONE (1) GRAND PRIZE: One (1) 2024 Lexus TX (MSRP: \$61,990). Grand Prize winner will be fully responsible for all applicable taxes, tag, title, insurance, and registration. Grand Prize winner must accept delivery of Grand Prize at a Dallas – Ft. Worth Area Lexus dealer to be designated by Sponsor. Grand Prize winner must show proof of insurance to take delivery of vehicle. Prize is provided with manufacturer's limited warranty; no other warranty or guarantee will be provided, either express or implied. Grand Prize winner has opportunity to upgrade vehicle package and select color of vehicle at sole cost of Grand Prize winner and subject to availability. Value of vehicle is not redeemable for cash or applied to another make of vehicle. Value of vehicle may be applied to another Lexus model. Grand Prize is non-transferable and cannot be substituted. Winner is responsible for all federal, state, and local taxes as well as any other costs and expenses associated with acceptance and use of the vehicle. All prize details are at Sponsor's sole discretion.

CLAIMING PRIZES/RELEASES: Potential Grand Prize winner will be notified by email and required to complete, execute and return an Affidavit of Eligibility, Liability and Publicity Release (except where prohibited by law) as well as a W9 form and any other required documents within fourteen (14) days of issuance. Potential Grand Prize winner will not be Grand Prize Winner until he/she signs and returns the Affidavit of Eligibility, Liability and Publicity Release and any other required documents and until these documents have been formally verified. If Grand Prize winner fails to comply with the Official Rules and/or to submit required documentation within the designated period, the Grand Prize will be forfeited and awarded to an alternate winner chosen at random by Sponsor.

Sponsor reserves the right at its sole discretion to disqualify any individual who: (1) tampers or attempts to tamper with the entry process or the operation of the Raffle; (2) violates these Official Rules; (3) acts in either an unsportsmanlike or disruptive manner; or, (4) acts with the intent to annoy, abuse, threaten or harass any other person. Sponsor and Related entities are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered, postage-due or garbled Entries, emails, notifications, mail, or other communications of any kind; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Raffle, including, without limitation, errors or difficulties which may occur in connection with the administration of the Raffle, the processing of entries, the announcement of the prize or in any Raffle-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Raffle. Released Parties are not responsible for injury or damage to participants' or to any other person's computer or other device related to or resulting from participating in this Raffle. Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Raffle should any portion of the Raffle be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries. If terminated, Sponsor may, at its discretion, select the potential winner from all eligible, non-suspect Entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. In the event of a dispute regarding Entries received from multiple users having the same e-mail account, the authorized subscriber of the e-mail account at the time of entry will be deemed to be the entrant and must comply with these Official Rules. Authorized account subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses.
