With each new year, the staff and partners of Children's Advocacy Center of Collin County reflect on the successes and challenges that have occurred in our fight against child abuse. This year, we have so much to be proud of. When The Speese Campus in McKinney opened in September 2022, we embraced the power of communication and teamwork as we operated two full-service facilities, never wavering in our goal of offering services to all children and families who need our help, without a waitlist.

The growth in northern Collin County has been astronomical. Incredibly, we have seen a 20% increase in services provided for cases in the northern part of our county, including forensic interviews, family advocacy and support, and therapy from our new, northern location. Through intense planning, research, and proactive action, our team was ready to answer the call as more reports of abuse occurred, while still providing the same quality of exceptional service at our original Plano facility.

As you read through this annual report, understand that the information here represents so much more than numbers on the page. It represents the fierce determination of our team in ensuring children receive the support they need, the power of a community taking a stand against child abuse, the resilience of our clients, and most importantly, the transformative power of hope.
