



LEXUS RAFFLE OFFICIAL RULES

Odds of Winning: 1 in 2,600. Need not be present to win.

- 1. ELIGIBILITY:** Entrants in the CACCC Vehicle Raffle (the "Raffle") must be legal U.S. residents who are at least 18 years of age on or before April 11, 2026, and who are licensed drivers possessing a valid U.S. driver's license. The Raffle is void outside of the U.S. and where prohibited or restricted by law.
- 2. SPONSOR:** Children's Advocacy Center of Collin County (CACCC), 2205 Los Rios Blvd., Plano, TX 75074 (hereinafter referred to as "Sponsor"). Employees of Sponsor, Southern Area Lexus Dealer Advertising Association, Inc., Toyota Motor Sales U.S.A., Inc., and their parent companies, subsidiaries, affiliates, divisions, advertising and promotion, and fulfillment and/or judging agencies (hereinafter, "Related Entities") and their spouses are not eligible. - 3. HOW TO ENTER:** To enter the Raffle complete the printed entry form at the bottom of this card by no later than April 11, 2026. Once you have completed the entry form and submitted the form as directed, your entry will be complete (hereinafter, "Entry"). Entry can also be completed by going to www.caccollincounty.org. The purchase of a Gala 2026 Lexus Vehicle Raffle ticket is NOT tax deductible.
- 4. WINNER SELECTION:** The potential Grand Prize winner will be chosen at random from all eligible Entries in accordance with these Official Rules. The winner selection will be made by a designated representative of Sponsor on April 11, 2026. The winner (and if the winner is a minor in his/her jurisdiction of residence, his/her parent or legal guardian) shall be required to execute and notarize an affidavit of eligibility and liability/publicity release and return such affidavit to Charity within fourteen (14) days or an alternative winner shall be drawn and contacted.
- 5. ONE (1) GRAND PRIZE:** One (1) 2026 Lexus RX (MSRP: \$51,175) is the grand prize (the "Grand Prize"). Grand Prize winner will be fully responsible for all applicable taxes, tag, title, insurance, and registration. The Grand Prize shall be awarded to the winner at Park Place Lexus Plano located at 6785 Dallas Pkwy, Plano, TX at a mutually agreeable date and time. The winner must execute all necessary paperwork and accept the Grand Prize on or before May 31, 2026. The Grand Prize is not redeemable for cash or applied to another make of vehicle. Value of the Grand Prize may be applied to another Lexus model. Grand Prize is non-transferable and may vary from images shown.
